The exercise price of \$6.56 reported on this Form 4 reflects an adjustment of \$1.12, which is the amount of a special dividend declared on November 16, 2006 and expected to be paid on November 21, 2006.
- (2) The options will vest in five equal annual installments on the first through fifth anniversaries of the grant date. The first installment will become exercisable on August 15, 2007.
