- (1) Each share unit represents the economic equivalent of one share of common stock. At time of distribution, Reporting Person will receive one share of common stock in exchange for each share unit, rounded up to the next whole share.  
Additional share units accrue when and as dividends are paid on the Company's common stock. The number of share units accrued will
- (2) be equal to the dollar amount of dividends that would be payable if the share units were actual shares of common stock, divided by the average of the high and low sale prices of a share of the Company's common stock on the date dividends are paid.
- (3) Delivery of shares of common stock in exchange for the share units will be made on the first business day in January following the calendar year in which Reporting Person ceases to be a director of the Company.
- (4) Reporting Person elected to defer \$12,000 of retainer and meeting fees for the fourth quarter 2008 in exchange for share units. The number of share units was determined by dividing \$12,000 by \$10.89, the average of the high and low sale prices of a share of the Company's common stock on December 31, 2008.
