We were unable, without unreasonable effort or expense, to finalize our audited consolidated financial statements as of and for the fiscal year ended December 31, 2012 in time to file our Annual Report on Form 10-K for the fiscal year ended December 31, 2012 (the "Form 10-K") by the filing deadline of 5:30 P.M., Eastern Time, on March 1, 2013. We transitioned from accelerated filer status to large accelerated filer status at the end of our 2012 fiscal year. As a result of this transition, the prescribed due date for the Form 10-K decreased from seventy-five days following the end of our 2012 fiscal year to sixty days following the end of our 2012 fiscal year. Due to this reduction of the filing window for the Form 10-K, we could not obtain all of the information and data necessary for the completion of the audited consolidated financial statements contained in the Form 10-K without unreasonable effort or expense. We will file the Form 10-K before the fifteenth calendar day following the prescribed due date.
