- (1) These shares comprise an award of restricted stock units granted to Mr. Fahey. Subject to acceleration in certain circumstances, 3,333 of the units are scheduled to vest on each of March 13, 2010 and March 13, 2011, and 3,334 of the units are scheduled to vest on March 13, 2012.
- (2) The reported aggregate amount, in addition to the 10,000 restricted stock units granted on March 13, 2009 and reported herein on Table I, includes 5,500 restricted stock units, scheduled to vest on March 7, 2010, and 9,334 restricted stock units, scheduled to vest on February 4, 2011, which units previously had been (and no longer will be) reported in Table II as derivative securities.
