### **bebe stores, inc. Announces March 2005 Sales; Same Store Sales Increase 30.6%**

BRISBANE, CALIF. April 7, 2005 bebe stores, inc. (Nasdaq: BEBE) today reported retail sales of \$49.7 million for the five-week period ended April 2, 2005, an increase of 42.4% compared to sales of \$34.9 million for the five-week period ended April 3, 2004.

Same store sales for the five-week period ended April 2, 2005 increased 30.6% compared to an increase of 20.5% for March 2004. For fiscal March 2005, same store sales were determined using a comparable period of 35 days.

Retail sales for the third quarter of fiscal 2005 were \$115.7 million, up 40.1% from \$82.6 million for the quarter beginning on January 4, 2004 and ending on April 3, 2004. Same store sales for the quarter increased 28.5% compared to an increase of 16.7% in the prior year.

Retail sales for the year-to-date period beginning July 1, 2004 and ending April 2, 2005 were \$370.2 million compared to \$277.0 million for the year-to-date period beginning July 3, 2003 and ending April 3, 2004, an increase of 33.6%. Same store sales for the year-to-date period beginning July 1, 2004 and ending April 2, 2005 increased 23.0% compared to an increase of 9.7% for the year-to-date period beginning July 1, 2003 and ending March 31, 2004.
