**Qualified holding Morgan Stanley**

Portugal Telecom, SGPS S.A. ( PT ) hereby informs that Morgan Stanley now holds more than 2% of the share capital of PT.

This change is due to Morgan Stanley & Co. International plc increasing, on 2 September 2014, borrowed positions in the amount of 3,623,035 PT ordinary shares. As a result, Morgan Stanley now holds a qualified holding corresponding to 2.38% of PT 's share capital and corresponding voting rights.

Additionally, PT was informed that this qualified holding is held as follows:

**Holdings in PT ordinary shares:**

- Morgan Stanley & Co. International plc: 17,037,114 ordinary shares representing 1.900% of the share capital and voting rights in PT;
- Morgan Stanley & Co. LLC: 4,105,558 ordinary shares representing 0.458% of the share capital and voting rights in PT;
- Morgan Stanley Capital Services LLC: 52,957 ordinary shares representing 0.006% of the share capital and voting rights in PT;
- Morgan Stanley Smith Barney LLC: 170,041 ordinary shares representing 0.019% of the share capital and voting rights in PT.

PT was further informed that the parent company Morgan Stanley controls Morgan Stanley & Co. International plc, Morgan Stanley & Co. LLC, Morgan Stanley Capital Services LLC and Morgan Stanley Smith Barney LLC, through the following chains of companies:
