**Item 8.01 Other Events.**

On September 22, 2014, The Coca-Cola Company (the Company) completed a public offering of \$800,000,000 aggregate principal amount of its 1.125% Notes due 2022 and \$1,200,000,000 aggregate principal amount of its 1.875% Notes due 2026 (collectively, the Notes).

The offering of the Notes was made pursuant to the Company's shelf registration statement on Form S-3 (Registration No. 333-191953) filed with the Securities and Exchange Commission (the SEC) on October 28, 2013, including a related prospectus and prospectus supplement filed with the SEC on October 28, 2013 and September 15, 2014, respectively.

The Notes were issued under an Amended and Restated Indenture, dated as of April 26, 1988 (as supplemented, the Indenture), between the Company and Deutsche Bank Trust Company Americas, as successor to Bankers Trust Company, as trustee, as supplemented by the First Supplemental Indenture, dated as of February 24, 1992, and the Second Supplemental Indenture dated as of November 1, 2007, between the Company and Deutsche Bank Trust Company Americas, as successor to Bankers Trust Company, as trustee.

The Indenture and amendments thereto, and the respective forms of global note for the offering, are filed as exhibits to this Form 8-K and are incorporated herein by reference.
