Stern Family Investors LLC (the [LLC]) hereby amends the Schedule 13D as of the date hereof, relating to the shares of common stock, par value \$.01 per share (the [Common Stock]), of Asta Funding, Inc. (the [Issuer]), as follows:

Item 5. Interest in Securities of the Issuer.

(a) Based upon the information contained in the Issuer's amended Registration Statement on Form S-1, as of June 27, 2003, there are issued and outstanding 6,209,483 shares of Common Stock.

(b) The LLC is deemed to beneficially own 346,000 shares of Common Stock or 5.6% of the shares of Common Stock. The LLC has sole power to vote or direct the vote and sole power to dispose or direct the disposition of the 346,000 shares of Common Stock.
