Item 1.02 Termination of a Material Definitive Agreement

On March 4, 2005, Ronald J. Prentki notified Progenics Pharmaceuticals, Inc. (the <code>[Company]]</code> of his resignation as President and Director of the Company. Mr. Prentki is leaving to pursue other interests. Mr. Prentki had served as President of the Company pursuant to an Employment Agreement dated May 16, 2001 (the <code>[Employment]]</code> Agreement. Under the terms of the Employment Agreement, Mr. Prentki will receive accrued salary, bonus and benefits and reimbursement of previously incurred expenses. Certain post-employment restrictions on Mr. Prentki will continue to apply. A description of the Employment Agreement is incorporated herein by reference from the Company[s] Definitive Proxy Statement on Schedule 14A filed with the Securities and Exchange Commission on April 15, 2004.

Item 5.02 Departure of Directors or Principal Officers; Election of Directors; Appointment of Principal Officers

On March 10, 2005, the Company announced the resignation of Ronald J. Prentki, its President and a Director, as discussed above. The Company also announced that its Board of Directors appointed Robert A. McKinney, currently the Vice President, Finance and Operations and Treasurer of the Company, to the additional office of Chief Financial Officer.
