Delaware Charter Guarantee & Trust Company dba Principal Trust Company acts as the Trustee of the 401(k) Plan Trust (collectively, the “Trust”). As of December 31, 2015. Frequency Electronics Inc. 401(k) Plan Trust held 749,075 shares of the Issuer's common stock.

- (a) The securities reported include all shares held of record by the Trustee. The Trustee follows the directions of the Employer, Frequency Electronics Inc. (the “Employer”), or other parties designated in the trust agreement between the Employer and the Trustee, with respect to voting and disposition of shares. The Trustee, however, is subject to fiduciary duties under ERISA. The Trustee disclaims beneficial ownership of the shares of common stock that are the subject of this Schedule 13G.

The 749,075 shares of common stock represent 8.58% of the Issuer's outstanding shares of common stock. The percent of class is based on shares outstanding as of December 31, 2016, as provided by the Issuer.
