On February 16, 2010, the Board approved a March 8, 2010 performance-adjusted restricted stock unit grant (RSUP14) of which 50% is reflected in table II. This award vests on March 8, 2013. Of the total shares granted, 50% of the shares are subject to forfeiture if the performance goals are not met. The full grant can be adjusted upward by an additional 50% if the 3-year goals are achieved.
