The phantom stock units and RSUs are automatically payable in shares of PG&E Corporation common stock only. This total also includes 4,062.92 shares held in the PG&E Corporation Dividend Reinvestment and Stock Purchase Plan (DRSPP), and reflects 144.31 shares of PG&E Corporation common stock acquired on 4/15/10, 143.56 shares on 7/15/10, 133.99 shares on 10/15/10, and 133.99 shares on 1/18/11 pursuant to a dividend reinvestment feature of the DRSPP.
