If such conditions are satisfied, each RSU entitles the holder to one share of AES Common stock for each RSU granted.

This stock option award was granted pursuant to The AES Corporation 2003 Long Term Compensation Plan. This award will vest in
 - (3) three equal annual installments such that one third will vest on 12/12/2015, one third will vest on 12/12/2016 and the remaining third will vest on 12/12/2017.

These units were awarded pursuant to the Restoration Supplemental Retirement Plan (the "Restoration Plan"). Generally, units under the
 - (4) Restoration Plan shall be paid out in cash following termination of employment or later as per the terms of the Restoration Plan document. Each unit represents a hypothetical AES investment equal to one share of AES Common Stock and units under the Restoration Plan are 100% vested upon award.
