- (1) As previously reported, on February 10, 2015, Mr. Rocha was granted 39,682 restricted stock units ("RSUs") representing rights to receive shares of common stock of SLM Corporation (the "Company") to vest in one-third increments on February 10, 2016, 2017 and 2018. On February 10, 2016, 13,227 shares vested in connection with these RSUs, of which 6,419 shares were withheld by the Company to satisfy Mr. Rocha's tax withholding obligations.
- (2) On February 10, 2015, a portion of Mr. Rocha's 2014 Management Incentive Plan Award was deferred in the form of vested RSUs that carry transfer restrictions that lapse in one-third increments on February 10, 2016, 2017 and 2018. On February 10, 2016, the restrictions lapsed on 6,778 RSUs, and 3,132 shares of the Company common stock were withheld to satisfy Mr. Rocha's tax obligations in connection with the lapsing of such restrictions.
