The balance includes 49.36 shares acquired via the issuer's dividend reinvestment and common stock purchase plan since the reporting person's last filing. The acquisitions are exempt from Section 16. The balance also includes 326.55 shares acquired via dividend reinvestment on October 2, 2015, January 5, April 4, July 5, and August 19, 2016 at prices ranging from \$38.58 to \$45.03 per share.

(1) Each share of Johnson Controls, Inc. ("Johnson Controls") was converted into 0.8357 ordinary shares of Johnson Controls International plc (formerly Tyco International plc) ("JCI plc") and \$5.7293 in cash in connection with the closing of the merger between Johnson Controls and JCI plc (the "merger").

(2) The options were converted into an equivalent number of options with respect to JCI plc at the same exercise price in connection with the closing of the merger.

(3) Fifty percent of the options become exercisable two years after grant date; the remaining 50%, three years after grant date.
