According to our latest records, we have not received your voting instructions for the important special meeting of stockholders of Kinder Morgan, Inc., to be held on Tuesday, December 19, 2006. For the reasons set forth in the proxy statement, dated November 15, 2006, your Board of Directors unanimously recommends that you vote FOR the merger proposal and FOR the proposal to approve any motion to adjourn the special meeting to a later date to solicit additional proxies if there are insufficient votes at the time of the special meeting to approve the merger.
