(1) On December 1, 2012, the Company granted 20,000 restricted shares under the Company's Long Term Compensation Program. The restricted shares vest in accordance with the provisions of the Restricted Stock Grant Agreement between the Issuer and the Reporting Person of same date on a straight-line basis 8.33% every ninety (90) days, during the three (3) years following the grant date. 654 of the 1,667 shares that vested February 24, 2014 were withheld to cover withholding taxes due upon vesting.
