All shares of the Issuer's Class A common stock were valued at the closing price on December 29, 2017.

Non-Employee Director Deferred Compensation Plan (previously filed as Exhibit 10.1 to the Issuer's quarterly report on Form 10-Q, filed with the Securities and Exchange Commission on November 9, 2009).
