FINANCING PRICE AND SIZE INCREASED

IMA Exploration Inc. is pleased to announce that due to an overwhelming demand for the \$1.2 million financing announced yesterday, the Company has increased the offering price to \$0.90 per unit and increased the financing size to \$2.61 million, subject to regulatory approval. Each unit will consist of one common share and one half of one common share purchase warrant. Each full warrant will entitle the holder thereof to purchase one additional common share in the capital of the Company for one year at \$1.10 per share.

Directors and officers of the Company will participate with \$1.2 million and First Associates Investments Inc. will lead the remaining \$1.4 million in a brokered private placement. No commission will be paid on the Directors and officers \$1.2 million, and a commission of 8% cash and 12 1/2 % broker warrants will be payable to First Associates Investments Inc. on the remaining \$1.4
