The Reporting Person exercised 45,000 vested Stock Appreciation Rights ("SARs") on May 20, 2010, resulting in the acquisition of 30,847 Class A Shares (settled for no additional consideration in accordance with the underlying SARs plan based on the difference

(2) between a 5-day volume weighted average trading price of Class A Shares equal to \$11.83 and a base value of each SAR equal to \$3.72), and elected to have a total of 20,189 Class A Shares withheld to satisfy tax withholding requirements. The Reporting Person did not sell any of the Class A Shares received upon exercise in the open market.

A total of 170,940 SARs were granted February 12, 2009, 33% vested on the first anniversary of the grant date, 33% vest on the second

(3) anniversary of the grant date, and 34% vest on the third anniversary of the grant date, and all such SARs expire on February 12, 2014. These SARs may be settled in cash or stock, at the discretion of the Issuer.
