Pursuant to a Purchase Agreement dated December 17, 2007, TGR Capital, LLC (which changed its name is Enerfund, LLC) in September 2008, a Florida limited liability company ("Enerfund"), which is wholly-owned by Mike Zoi, acquired all of the membership interests in Splinex LLC, thereby giving Enerfund control of Splinex LLC. Under an exchange Agreement dated December 18, 2007, TOT Energy, Inc. ("the Company") issues 113,500,000 shares of the Company to Splinex LLC of which 8,500,000 shares were issued to Bzinfin S.A., a British Virgin Islands limited liability corporation, and 2,125,000 were issued to a former affiliate of Splinex, LLC. After the completion of the Exchange Agreement, Splinex, LLC owned approximately 93.99% of the Company. In June 2008, Splinex, LLC changed its name to TGR energy, LLC ("TGR").

- (2) Pursuant to Subscription Agreement dated August 7, 2008, as amended on December 6, 2009, between TGR and the Company (the "subscription Agreement"), for the quarter ended June 30, 2010, TGR was issued 10,037,315 shares of common stock of the Company and fully vested five year warrants to purchase 5,019,157 shares of common stock of the Company for \$0.05 per share in exchange for funding of 200,746 provided during the quarter under the terms of Subscription Agreement.
