The Registrant expects to report a net loss of approximately \$(1,846,098) on revenues of approximately \$3,931,000 for the twelve months ended December 31, 2012 compared to net loss of approximately \$(1,210,000) on revenues of approximately \$5,688,000 for the year ended December 25, 2011. The anticipated increase in net loss is primarily due to the significant amount of low margin revenues and declining overall revenue.
