**Item 7.01 Regulation FD Disclosure.**

On February 4, 2013 PBF Energy Inc. (the “Company”) issued a press release announcing the completion of a new crude unloading facility at its Delaware City refinery and the arrival of the first unit trains at the refinery’s new facility.
