The Reporting Person has acquired 18,368 shares of common stock of iStar Financial Inc. in settlement of vested common stock equivalent ("CSE") awards received by the Reporting Person, pursuant to the iStar Financial Inc. Non-Employee Directors' Deferral Plan ("Plan"). Under the Plan, the Reporting Person has received annual CSE awards effective as of the date of each annual meeting of shareholders beginning with the 2003 annual meeting. In addition, the Reporting Person has elected to have additional CSEs credited to his account in respect of dividend equivalent payments on his CSEs. In accordance with the Plan, the Reporting Person has elected to receive a distribution of his vested CSEs in the form of shares of iStar common stock.

Following this transaction, the Reporting Person beneficially owns a total of 68,368 shares of iStar common stock, consisting of 17,550 (2) shares owned indirectly in an individual retirement account established by the Reporting Person and 50,818 shares owned indirectly as trustee of a family trust.
