The 19,6658 dividend equivalent rights being reported reflect 9,7056 dividend equivalent rights at \$42.26 per RSU credited to the reporting person's account on 12/30/10 and 9,9602 dividend equivalent rights at \$41.18 per RSU credited to the reporting person's account on 04/06/11. These RSUs cliff vested on 04/19/11, at which time the vested shares were delivered to the reporting person.
