(1) Incentive Stock Options ("ISO") granted by the Issuer to Mr. Adams under the Issuer's Stock Option Plans. The ISO is for a term of ten years from the grant date. The ISOs are fully vested at the end of year four and all options were fully vested as of December 31, 2005.
