Each share of phantom stock is the economic equivalent of one share of common stock, \$0.01 par value per share, of the Company. The shares of phantom stock are payable in cash and generally only after the reporting person is no longer a member of the Company's board of directors. These shares of phantom stock are in addition to the 30,161 shares of phantom stock previously held by the reporting person in the Deferred Compensation Plan.
