 In addition to the grant of 2,085 restricted stock units reported herein, the total also includes 1,302 other restricted stock units granted pursuant to the Markel Corporation Omnibus Incentive Plan, of which 803 units will vest on December 31, 2010, 265 units will vest on December 31, 2011, and 234 units will vest on December 31, 2012.
