- (1) The transactions reported on this Form 4 were effected pursuant to a Rule 10b5-1 trading plan adopted by the Reporting Person on December 14, 2012.  
The sale prices reported in column 4 of Table 1 represent the weighted average sale price of the shares sold ranging from \$98.07 to \$99.03 and \$99.09 to \$99.79, per share, respectively. Upon request by the Commission staff, the Issuer, or a security holder of the Issuer, the Reporting Person will provide full information regarding the number of shares sold at each separate price.
- (2) This option is subject to an early exercise provision and is immediately exercisable. One ninety-sixth of the original shares subject to the option vested on January 30, 2006 and one ninety-sixth of the shares vest monthly thereafter.
- (3) This option vests in forty-eight equal monthly installments beginning on September 15, 2009.
- (4) This option vests in forty-eight equal monthly installments beginning on April 3, 2010.
