- (1) The transactions reported on this Form 4 were effected pursuant to a Rule 10b5-1 trading plan adopted by the Reporting Person on December 14, 2012.

The sale prices reported in column 4 of Table 1 represent the weighted average sale price of the shares sold ranging from \$98.53 to \$99.46, \$99.69 to \$100.59, and \$100.69 to \$101.26, per share, respectively.
