The reporting person is a participant in the Atlas Pipeline Partners, L.P. 2010 Long-Term Incentive Plan (the "Plan"). The reporting person received 15,000 phantom units under the Plan on February 18, 2014. Each phantom unit represents the right to receive, upon

- (1) vesting, one common unit of limited partnership interest of the Partnership. The phantom units will vest over a three year period, with 33% vesting on the first anniversary of the grant date, 33% vesting on the second anniversary of the grant date and 34% vesting on the third anniversary of the grant date. The units are receivable without additional consideration.
- (2) 72,500 of these common units remain subject to vesting schedules.
