Item 3.02 Unregistered Sales of Equity Securities

On June 19, 2015, the Registrant accepted a conversion notice from JMJ Financial, ("JMJ") to partially satisfy a \$550,000 Promissory Note ("the JMJ Note") dated July 11, 2012 with JMJ. 18,000,000 shares were subsequently issued to satisfy \$2,520 of the outstanding principal and interest in accordance with the terms of the JMJ Note. As of the date of this report the remaining amount currently outstanding on the JMJ Note, including accrued interest, is now \$71,003.

On June 30, 2015, the Registrant accepted a conversion notice from KBM Worldwide, Inc. ("KBM ") to partially satisfy a \$98,500 Convertible Promissory Note Agreement ("the KBM Note") dated August 6, 2014 with KBM. An aggregate of 19,500,000 shares were subsequently issued to satisfy \$2,925 of the outstanding principal in accordance with the terms of the KBM Note. As of the date of this report the remaining amount currently outstanding on the KBM Note is \$73,375.

On July 1, 2015, the Registrant accepted a conversion notice from LG Capital Funding LLC ("LG") to partially satisfy a \$33,000 Promissory Note ("the LG Note #2") dated February 3, 2014, with LG. 25,409,214 shares were subsequently issued to satisfy \$3,557 of the outstanding principal and interest in accordance with the terms of the LG Note #2. As of the date of this report the remaining amount currently outstanding on the LG Note #2, including accrued interest, is now \$13,700.

JMJ, KBM, and LG are each an "accredited investor" as defined under Rule 501 of Regulation D. The Company believes that these transactions are exempt from registration with the Securities and Exchange Commission pursuant to Section 4(2) of the Securities Act of 1933, as amended.

The above described executed Notes are attached hereto and incorporated by reference as Exhibits 10.1 through 10.3.

As of the date of this report the Registrant has 423,777,263 shares of its common stock issued and outstanding and 423,619,153 shares in the public float.
