Unilever NV also announces that 3,984 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 84,232,966 Unilever NV ordinary shares in treasury, and has 1,630,494,734 Unilever NV ordinary shares in issue (excluding treasury shares).
