### Item 1.01 Entry into a Material Definitive Agreement.

On September 13, 2005, the Compensation Committee of the Board of Directors approved an increase in the annual salary of David F. Dougherty, who was elected to the position of President and Chief Operating Officer of Convergys on September 6, to \$545,000. Mr. Dougherty s annual incentive bonus target was also increased, however, the performance criteria that will be used to determine the actual bonus payout remains unchanged.
