OceanFirst Financial Corp. (the Company) is unable, without unreasonable effort or expense, to file its Annual Report on Form 10-K for the year ended December 31, 2006, and, therefore, files this Form 12b-25 for a 15 day extension from March 16, 2007 to March 31, 2007. The Company will be unable to complete the preparation of its consolidated financial statements by the initial filing date as a result of the Company's determination to establish a reserve for repurchased loans for loans initially originated by the Company's subsidiary, Columbia Home Loans, LLC. The Company previously announced in a press release filed on March 12, 2007 that the Company is in the process of determining the amount of the reserve and that the Company will be revising its earnings previously reported in a press release on January 18, 2007.

In light of the above, the Company is unable to file its Annual Report on Form 10-K without unreasonable effort or expense.
