(d) On April 23, 2008, the Board of Directors (the Board ) of NCR Corporation, a Maryland corporation (NCR), elected Richard Clemmer and Robert DeRodes each as a member of the Board. The Board designated Mr. Clemmer as a Class C director and Mr. DeRodes as a Class A director. Messrs. Clemmer and DeRodes will each stand for election at the NCR 2009 Annual Meeting of Stockholders.
