**EXPLANATORY NOTE**

This Registration Statement is being filed, in accordance with General Instruction E. to Form S-8, solely to register the issuance of up to 600,000 additional shares of Common Stock of Microtune, Inc. authorized pursuant to the amendment and restatement of the Amended and Restated Microtune, Inc. 2000 Employee Stock Purchase Plan (the "2000 Employee Stock Purchase Plan"). We previously filed with the Securities and Exchange Commission (the "SEC") Registration Statements Nos. 333-150537, 333-144882, 333-120091 and 333-47646 relating to the 2000 Employee Stock Purchase Plan on April 30, 2008, July 26, 2007, October 29, 2004 and October 10, 2000, respectively (collectively, the "Prior Registration Statements"). Except as supplemented by the information set forth below, the contents of each of the Prior Registration Statements are incorporated herein by reference.
