This prospectus supplement relates to 43,718 shares of our common stock issued to the entities named under the heading Resales of Shares as part of the purchase price we paid in connection with certain earnout payments we paid on November 13, 2009 in connection with the acquisition of certain insurance brokerage businesses from BIS Insurance Services, Inc. and Dale L. Waters Insurance Services, Inc. This prospectus supplement and the related prospectus may be used to resell our shares only by the individuals named under the heading Resales of Shares and their permitted transferees. You should read this supplement in conjunction with the prospectus and subsequent supplements.
