**CALGARY, Alberta, October 28, 2011** Enbridge Inc. (TSX, NYSE: ENB) announced today that its Board of Directors has declared a quarterly dividend of \$0.245 per common share, payable on December 1, 2011 to shareholders of record on November 15, 2011.

In addition, the Board declared a quarterly dividend of \$0.34375 per Series A Preferred Share payable on December 1, 2011 to shareholders of record on November 15, 2011.
