**Item 8.01 Other Events.**

Throughout this document, AT&T Inc. is referred to as AT&T. On March 13, 2013, AT&T closed its sale of 1,250,000,000 principal amount of its 2.500% Global Notes due 2023 (the 2023 Notes ) and 400,000,000 principal amount of its 3.550% Global Notes due 2032 (the 2032 Notes and, together with the 2023 Notes, the Notes ) (cumulatively, equivalent in total to approximately U.S.\$2,145,825,000 based on the March 6, 2013 exchange rate), pursuant to the Underwriting Agreement dated March 6, 2013 (the Underwriting Agreement ), between AT&T and BNP Paribas, Credit Suisse Securities (Europe) Limited and UBS Limited, as the several Underwriters. The Notes were issued pursuant to that certain Indenture dated as of November 1, 1994 between SBC Communications Inc. (now known as AT&T Inc.) and The Bank of New York Mellon, as Trustee. The Notes have been registered under the Securities Act of 1933 (the Act ) pursuant to a Registration Statement on Form S-3 (No. 333-165543) previously filed with the Securities and Exchange Commission (the Commission ) under the Act. Copies of the Underwriting Agreement and the forms of Note are filed as exhibits hereto and incorporated herein by reference. AT&T is filing this Current Report on Form 8-K so as to file with the Commission certain items that are to be incorporated by reference into its Registration Statement.
