Wright is the beneficial owner of 10,400 shares of common stock of the issuer, or approximately 0.3%, for a total aggregate percentage of 5.2%. Henry Investment Trust, L.P. is the general partner of each of Henry Partners, L.P. and Matthew Partners, L.P. David W. Wright is the investment manager of each of Henry Partners, L.P. and Matthew Partners, L.P. and is the President of Canine Partners, LLC, the general partner of Henry Investment Trust, L.P.
