**ChipMOS REPORTS AUGUST 2013 REVENUE**

**Hsinchu, Taiwan, September 10, 2013** - ChipMOS TECHNOLOGIES (Bermuda) LTD. ( ChipMOS or the Company ) (NASDAQ: IMOS), an industry leading provider of outsourced semiconductor assembly and test services ( OSAT ), today reported its unaudited consolidated revenue for the month of August 2013.

Revenue for the month of August 2013 was NT\$1,713.1 million or US\$57.2 million, a decrease of 0.3% from the month of July 2013 and a decrease of 1.6% from the same period in 2012. All U.S. figures in this release are based on the exchange rate of NT\$29.93 to US\$1.00 as of August 30, 2013.
