<b>Optional Redemption:</b>	The 4.05% Notes due 2046 are redeemable at the option of the Company, in whole but not in part, on each August 1 on or after August 1, 2019. This redemption would be at a redemption price equal to 100% of the principal amount of the notes being redeemed plus accrued and unpaid interest to the redemption date.
<b>Redemption for Tax Reasons:</b>	The 4.05% Notes due 2046 are redeemable, in whole but not in part, in the event of certain changes in the tax laws of the United States (or any taxing authority in the United States). This redemption would be at a redemption price equal to 100% of the principal amount of the notes being redeemed plus any accrued interest and additional amounts then payable with respect to the notes to, but not including, the redemption date.
<b>Further Issuances:</b>	To the extent permitted by applicable authorities in the Republic of China and subject to the receipt of all necessary regulatory and listing approvals from such authorities, including but not limited to the Taipei Exchange ( <b>TPEX</b> ) and the Taiwan Securities Association, an unlimited amount of further 4.05% Notes due 2046 may be issued. The 4.05% Notes due 2046 and any further 4.05% Notes due 2046 that may be issued may be treated as a single series for all purposes under the indenture.
<b>Listing:</b>	Application will be made for the 4.05% Notes due 2046 to be listed on the TPEX.
<b>ROC Selling Restrictions:</b>	The notes have not been, and shall not be, offered, sold or re-sold, directly or indirectly, to investors other than professional institutional investors as defined under Paragraph 2 of Article 4 of the Financial Consumer Protection Act of the Republic of China. Purchasers of the notes are not permitted to sell or otherwise dispose of the notes except by transfer to the aforementioned professional institutional investors.
