(1) Award of restricted shares as 2011 annual long-term incentive compensation pursuant to the Company's 2004 Equity Incentive Plan, as amended. These restricted shares vest one-fifth on the date of grant, one-fifth on each of January 1, 2013 and 2014 and the remainder of

the restricted shares vest January 1, 2015.

- (2) On March 7, 2012, 3,419 restricted shares vested and the Reporting Person instructed the Company to withhold 1,076 shares to cover tax withholding obligations as permitted under the Company's 2004 Equity Incentive Plan, as amended.
- (3) Award of restricted shares as 2011 multi-year long-term incentive compensation pursuant to the Company's 2004 Equity Incentive Plan, as amended. These restricted shares vest one-fourth on the date of grant, and one-fourth on each of January 1, 2013, 2014 and 2015.
- (4) On March 7, 2012, 4,274 restricted shares vested and the Reporting Person instructed the Company to withhold 1,344 shares to cover tax withholding obligations as permitted under the Company's 2004 Equity Incentive Plan, as amended.
- (5) As of the date hereof, the Reporting Person's direct beneficial ownership includes 68,883 restricted shares granted under the Company's 2004 Equity Incentive Plan, as amended, that have not yet vested.
