- As previously reported, the reporting person also indirectly owns shares that are beneficially owned directly by Continental Power Exchange, Inc. ("CPEX"). Prior to the reported transactions, the reporting person beneficially owned 98.5% of the equity interest in CPEX directly and held an irrevocable proxy to vote the remaining 1.5%. As a result of the reported transactions filed on Forms 4 dated
- (1) December 19, 2006, the reporting person has acquired 100% of the equity interest in CPEX. Additionally, as previously reported, the reporting person also indirectly owns shares that are beneficially owned directly by the reporting person's spouse for which the reporting person disclaims beneficial ownership.
 - (2) The sales reported in this Form 4 were effected pursuant to a previously disclosed Rule 10b5-1 trading plan adopted by the reporting person on May 16, 2006.
 - (3) These options are fully vested.
