- Pursuant to the Endo Pharmaceuticals Directors Stock Election Plan, on December 18, 2009, Mr. Scodari elected to receive 100% of his meeting fees in Endo common stock. At the time that the meeting fees would otherwise have been payable, the number of shares of Endo
