## Explanation of Responses:

- (1) Pursuant to the terms of a restricted stock agreement, the vesting schedule of this restricted stock is 25% on February 1, 2012; an additional 6.3% to vest on a day to be randomly determined in each of the next 11 calendar quarters (provided that in no event shall the days so chosen in two consecutive calendar quarters be less than 60 days apart from each other) following February 1, 2012; and the remainder of the total award to vest on February 1, 2015.
- (2) Shares subject to these options vest as to 25% of such shares on the first anniversary of the date of grant and as to the remaining shares in 36 approximately equal monthly installments beginning one month thereafter.
