(1) On July 29, 2011, the reporting person was granted 25,000 performance share units (PSUs) under the Company's 2008 Incentive Compensation Plan. Each PSU represents a contingent right to receive one share of common stock. On June 14, 2012, the pre-established performance goal for this award was met and 50% of the PSUs vested on July 29, 2012 and were converted into common stock. The remaining PSUs will vest and convert on July 29, 2013.
