(1) The sale of 500 shares as reported in this Form 4 were sold pursuant to a sale plan adopted by the reporting person on August 2, 2012, pursuant to Rule 10b5-1 under the Securities Exchange Act of 1934.

(2) Aggregate of 20,751.04 shares listed in Column 5 of Table I includes: (a) 3,700 performance shares previously reported and subject to adjustment and (b) 55.07 shares acquired through the Harris Corporation 401(k) Retirement Plan from 9/5/12 through 11/20/12.

(3) Each phantom stock unit is the economic equivalent of one share of the Issuer's common stock.

(4) The phantom stock units were accrued under the Harris Corporation Supplemental Executive Retirement Plan. Phantom stock units are to be settled in cash upon the reporting person's retirement or other events.
