- Represents 20% vesting on March 7, 2015. The original grant was 1508 restricted stock units, with 20% vesting on March 7, 2015, and
- (1) the remaining 80% vesting in equal quarterly installments over the remaining 4 years. This grant of restricted stock units was previously reported as 754 shares, but has been adjusted to reflect the 2-for-1 stock split that occurred on April 1, 2014.
  - (2) Each restricted stock unit represents the right to receive, following vesting, one share of Pegasystems Inc.'s common stock
  - (3) Once vested, the shares of common stock are not subject to expiration.
